

AN ORDINANCE TO AMEND ORDINANCE 1660-2019 "MAKE APPROPRIATIONS FOR CURRENT EXPENSES AND OTHER EXPENDITURES OF THE VILLAGE OF LAKEMORE, STATE OF OHIO. DURING THE FISCAL YEAR ENDING DECEMBER 31, 2020"

Now, Therefore, Be it Ordained by the Council of the Village of Lakemore, County of Summit, State of Ohio:

Section 1: Council approves to increase appropriations in:
General Fund Legal Professional Technical \$14,200.00 to afford \$8200.00 Akron Prosecutor Services for 2019 services and \$6000.00 for Walter Haverfield Attorneys at Law legal services for first quarter 2020.

Fire Levy Fund \$16,500.00 to afford a shift supervisor four additional days with holidays through 2020.

Section 2: Treasury for payments from any of the forgoing appropriations upon receiving proper certificates and vouchers therefore, approved by the board or officers authorized by law to approve the same, or an ordinance or resolution of Council to make the expenditures; provided that no warrants shall be drawn or paid for salaries or wages except to persons employed by authority of and in accordance with law or ordinance. It shall be provided further that the appropriations for contingencies can only be expended upon appeal of two-thirds vote of Council for items of expense constituting a legal obligation against the village for purposes other than those covered by other specific appropriations herein made.

Section 3: This Ordinance shall go into effect on and after the earliest period allowed by law.
