MINUTES FOR COUNCIL MEETING
NOVEMBER 2, 2020

Meeting Was Called to Order by Mayor Cole at 7:02 p.m.

Opening Roll Call: Mrs. Coontz, Mrs. Cochran, Ms. Snyder, Mr. Strittmatter, Ms. Anderson, and Mr. Douglas were present.


