AN ORDINANCE TO AMEND ORDINANCES NO 1549-2015 “MAKE APPROPRIATIONS FOR CURRENT EXPENSES AND OTHER EXPENDITURES OF THE VILLAGE OF LAKEMORE, STATE OF OHIO, DURING THE FISCAL YEAR ENDING DECEMBER 31, 2016”


Be it Ordained by the Council of the Village of Lakemore, Ohio:

- Section 1: Council approves to increase the following revenues:
Fund 1000 General \$84,500.00 for additional income tax and licenses/permits
Fund 4202 CDBG \$199,762.11 for the additional CDBG funds approved for 2016
- Section 2: Council approves to decrease the following appropriations:
Fund 2052 Lakemore Fire/EMS Grants \$120,000.00 to reflect only the received and approved grants
- Section 3: Council approves to increase the following appropriations:
Fund 5101 Water Enterprise \$85,000.00 for professional services to afford improvements to the high-level water tower
- Section 4: Council approves to re-appropriate the following appropriations:
Fund 5101 Water Enterprise \$60,000.00 from operating supplies and materials to professional services to afford improvements to the high-level water tower and to clean to low-level water tower
- Section 5: And the Village Fiscal Officer is hereby authorized to draw warrants on the Village Treasurer for payments from any of the foregoing appropriations upon receiving proper certificates and vouchers therefore, approved by the board or officers authorized by law to approve the same, or an ordinance or resolution of council to make the expenditure; provided that no warrants shall be drawn or paid for salaries or wages except to persons employed by authority of and in accordance with law or ordinance. It shall be provided further that the appropriations for contingencies can only be expended upon appeal of two-thirds vote of Council for items of expense constituting a legal obligation against the


village and for purposes other than those covered by other specific appropriations herein made.

Section 6: This Ordinance is hereby declared to be an emergency measure necessary for the immediate preservation of the health, safety and welfare of the citizens of the Village of Lakemore, Ohio, for the reason that the appropriation is necessary for the continued operation of the Village of Lakemore. Therefore, this Ordinance shall go into effect immediately.
