WHEREAS, Motorola has deemed the Watchguard Vista system to be obsolete and will no longer be supported

Now Therefore, Be it Resolved by the Council of the Village of Lakemore, County of Summit, and State of Ohio:

Section 1: The Village of Lakemore Police Department is seeking to replace the Watchguard Vista body and video evidence system.

Section 2: Motorola has provided a quote for the lease-to-own option for VB400 Video Management system. A copy of the quote is attached hereto and made part of as if fully re-written herein.

Section 3: Mayor and Council approve to enter into the lease-to-own agreement with Motorola.

Section 4: It is hereby found and determined that all formal actions of this Council concerning and relating to the adoption of this Resolution were adopted in an open meeting of this Council, and that all deliberations of this Council and of any of its committees that resulted in such formal action, were in meetings open to the public, in compliance with all legal requirements, including Section 121.22 of the Ohio Revised Code.
