effective; therefore this resolution shall take effect immediately.



**AN ORDINANCE AUTHORIZING ALL ACTIONS  
NECESSARY TO ACCEPT NORTHEAST OHIO  
PUBLIC ENERGY COUNCIL (NOPEC) 2021  
ENERGIZED COMMUNITY GRANT(S) FUNDS**

**WHEREAS**, the Village of Lakemore, Ohio (the "GRANTEE") is a member of the Northeast Ohio Public Energy Council ("NOPEC") and is eligible for one or more NOPEC Energized Community Grant(s) for 2021 ("NEC Grant(s)") as provided for in the NEC Grant Program guidelines; and

**WHEREAS**, the GRANTEE has previously entered into a Grant Agreement with NOPEC, Inc. on March 1, 2021 to receive one or more NEC Grant(s).

**NOW, THEREFORE**, BE IT ORDAINED BY THE COUNCIL OF THE Village of Lakemore, COUNTY OF Summit, AND STATE OF OHIO, THAT:

**SECTION 1.** This Council of the GRANTEE (the "Council") finds and determines that it is in the best interest of the GRANTEE to accept the NEC Grant(s) for 2021, and authorizes the Mayor to accept the NEC Grant(s) funds.

**SECTION 2.** This Council finds and determines that all formal actions of this Council concerning and relating to the adoption of this Ordinance were taken in an open meeting of this Council and that all deliberations of this Council and of any committees that resulted in those formal actions were in Meetings open to the public in compliance with the law.

**SECTION 3.** This Ordinance shall go into effect on and after the earliest period allowed by law.

AN ORDINANCE TO AMEND ORDINANCE 1336-2003 "POLICIES AND PROCEDURES MANUAL"  
AND ORDINANCE 1425-2010 "PURCHASE ORDER POLICY"

Now, Therefore, Be it Ordained by the Council of the Village of Lakemore, County of Summit, State of Ohio:

Section 1: Council agrees to amend the Purchase order policy defined in Ordinance 1425-2010 and included in Ordinance 1336-2003 to read

SECTION 3.06 PURCHASE ORDER POLICY (ORD 1425-2010)

E. Blanket and Super Blanket Purchase Orders shall be limited to an amount not to exceed fifteen thousand dollars (\$15,000.00). This will allow the Fiscal Officer to encumber proper amounts for such purchases as fuel, capital improvements, and supplies at the beginning of the year and be approved by Council at the beginning of the year. Purchase Orders for specific vendors will be approved by Council prior to any payments.

Section 2: All ordinances, resolutions and parts of ordinances and resolutions which are in conflict with this Ordinance are hereby repealed. Those ordinances, resolutions, and parts of ordinances and resolutions which are not in conflict with any provision of this Ordinance are hereby expressly excepted from repeal by this Ordinance and shall continue in full force and effect until otherwise amended or repealed by Council

Section 3: That this Ordinance shall be in effect from and after the earliest period allowed by law.
