AN ORDINANCE TO AMEND ORDINANCE 1809-2023 TO CHANGE THE EFFECTIVE
DATE FROM JULY 1, 2023 TO OCTOBER 1, 2023

Now, Therefore, Be it Ordained by the Council of the Village of Lakemore, County of Summit,
State of Ohio:

Section 1: Council approves to amend Ordinance 1809-2023 to change the effective date
from July 1, 2023 to October 1, 2023.

Section 2: All ordinances, resolutions and parts of ordinances and resolutions which are
in conflict with this Ordinance are hereby repealed. Those ordinances,
resolutions, and parts of ordinances and resolutions which are not in conflict
with any provision of this Ordinance are hereby expressly excepted from
repeal by this Ordinance and shall continue in full force and effect until
otherwise amended or repealed by Council

ORDINANCE NO 1814-2023

AN ORDINANCE TO AMEND ORDINANCE 1795-2022 “MAKE APPROPRIATIONS FOR CURRENT EXPENSES AND OTHER EXPENDITURES OF THE VILLAGE OF LAKEMORE, STATE OF OHIO. DURING THE FISCAL YEAR ENDING DECEMBER 31, 2023”

Now, Therefore, Be it Ordained by the Council of the Village of Lakemore, County of Summit, State of Ohio:

Section 1: Council approves to increase appropriations in:
General Fund \$45,095.21 for an overpayment of the special assessment by Summit County
Note Principal on Police Facility Fund 3102 \$500,000 to pay invoices from the renovations project

Section 2: Treasury for payments from any of the forgoing appropriations upon receiving proper certificates and vouchers therefore, approved by the board or officers authorized by law to approve the same, or an ordinance or resolution of Council to make the expenditures; provided that no warrants shall be drawn or paid for salaries or wages except to persons employed by authority of and in accordance with law or ordinance. It shall be provided further that the appropriations for contingencies can only be expended upon appeal of two-thirds vote of Council for items of expense constituting a legal obligation against the village for purposes other than those covered by other specific appropriations herein made.

Section 3: This Ordinance is hereby declared to be an emergency measure necessary for the immediate preservation of the health, safety, and welfare of the citizens of the Village of Lakemore, Ohio. Therefore, this Ordinance shall go into effect immediately.
