AN ORDINANCE TO AMEND ORDINANCE 1631-2018 "MAKE APPROPRIATIONS FOR CURRENT EXPENSES AND OTHER EXPENDITURES OF THE VILLAGE OF LAKEMORE, STATE OF OHIO. DURING THE FISCAL YEAR ENDING DECEMBER 31, 2019"

Now, Therefore, Be it Ordained by the Council of the Village of Lakemore, County of Summit, State of Ohio:

Section 1: Council approves to increase appropriations in:  
General 1000-110-211 Police OPERS \$6000.00 to afford to end of year  
General 1000-320-399 Park Contractual \$2000.00 to repair fence and sign at WW park  
Fire Grants 2052-160-400 \$8117.00 to re-appropriate reimbursement for EMS software  
Police Disability 2131-110-215 OP&F Police \$10,000.00 to afford to end of year  
Capital Improvement 4901-610-555 Street & Hwy \$20,000.00 to afford chip & seal  
Water 51501-531-349 Professional Srvc \$5000.00 for additional engineering for  
Restore Addiction additional waterline  
Water 5101-531-430 Repairs & Mntnce \$1500.00 Repair roof on Wellhouse #1

Section 2: Treasury for payments from any of the forgoing appropriations upon receiving proper certificates and vouchers therefore, approved by the board or officers authorized by law to approve the same, or an ordinance or resolution of Council to make the expenditure; provided that no warrants shall be drawn or paid for salaries or wages except to persons employed by authority of an in accordance with law or ordinance. It shall be provided further that the appropriations for contingencies can only be expended upon appeal of two-thirds vote of Council for items of expense constituting a legal obligation against the village for purposes other than those covered by other specific appropriations herein made.

Section 3: This Ordinance is hereby declared to be an emergency measure necessary for the immediate preservation of the health, safety, and welfare of the citizens of the Village of Lakemore, Ohio, for the reason that the appropriation is necessary for the continued operation of the Village of Lakemore. Therefore, this Ordinance shall go into effect immediately.

Section 1: Council authorizes the Mayor to accept the estimate from Perrin Asphalt for \$255 tons of pavement leveling for \$35,700.00.


Section 2: Council authorizes the Mayor to accept the estimate from H.Luli Construction Company to chip and seal the following streets for \$35,062.50:



Now Therefore, Be it Resolved by the Council of the Village of Lakemore, County of Summit, and State of Ohio:


- Section 1: Council confirms the promotion of Garry Orr to Captain with the Lakemore Fire Department, effective immediately.
