EMERGENCY RESOLUTION TO AMEND RESOLUTION 6270-2009 BY INCREASING THE FIRE DEPARTMENT ROSTER TO A MAX OF 30 EMPLOYEES. THIS RESOLUTION IS TO ALLOW THE ACTING FIRE CHIEF TO HAVE AN ADEQUATE FIREFIGHTING FORCE AVAILABLE TO PREPARE FOR, RESPOND TO AND MITIGATE ANY EMERGENCY SITUATIONS IN THE VILLAGE OF LAKEMORE

Be it Resolved by the Council of the Village of Lakemore, Ohio:

Section 1: Council authorizes the Acting Fire Chief to hire volunteer/paid per call firefighters as needed to fill the Fire Department roster to a max of 30 employees. This Resolution is to allow the Acting Fire Chief to have an adequate firefighting force available to prepare for, respond to and mitigate any emergency situations in the Village of Lakemore.

Section 2: All appointments are contingent upon the approval of council of the appointments and to the passing of medical assessments and physical endurance testing.

Section 3: This Resolution is hereby declared to be an emergency measure necessary for the immediate preservation of the public health, safety and welfare of the citizens of the Village of Lakemore, Ohio for the reason that a properly staffed Fire Department is essential for the safety of the residents of the Village of Lakemore. Therefore, this Resolution shall take effect immediately.


Be it Resolved by the Council of the Village of Lakemore, Ohio:
