

A RESOLUTION AUTHORIZING THE FIRE CHIEF AND MAYOR TO HIRE ROSS HARMON, JAMES CHAPMAN, AARON HOXWORTH, AND VINCENT SFERRA AS PROBATIONARY FIREFIGHTER/PARAMEDICS FOR THE LAKEMORE FIRE DEPARTMENT

Now, Therefore, Be it Resolved by the Council of the Village of Lakemore, Ohio:

- Section 1: The Fire Chief and Mayor are authorized to hire Ross Harmon, James Chapman, Aaron Hoxworth, and Vincent Sferra as probationary Firefighter/Paramedics for the Lakemore Fire Department.
- Section 2: Each candidate shall comply with requirements as provided in Section V Subparagraph E of the Fire Department Manual pending required examinations and background check.
- Section 3: No funds will be spent for the initial training, as each candidate possesses the necessary training already.
- Section 4: This Resolution is hereby declared to be an emergency measure necessary for the immediate preservation of the public health, safety, and welfare of the citizens of the Village of Lakemore, Ohio as the department must maintain sufficient staffing. Therefore, this Resolution shall take effect immediately.

A RESOLUTION AUTHORIZING THE MAYOR TO HIRE CHRISTOPHER
ALDERMAN AS A FULL-TIME LABORER WITH THE LAKEMORE
DEPARTMENT OF PUBLIC SERVICES

Be it Resolved by the Council of the Village of Lakemore, Ohio:

Section 1: That the Council authorizes the Mayor to hire Christopher Alderman as a full-time laborer with the Lakemore Department of Public Services.
