Section 4: The Village Police Chief or Marshall shall have exclusive control of the stationing and transferring of all auxiliary police officers, under such general rules as the Mayor prescribes.

Section 5: All Ordinances or Resolutions or parts of Ordinances or Resolutions inconsistent herewith are hereby repealed. All Ordinances and Resolutions which are not inconsistent herewith are hereby confirmed.

Section 6: This Ordinance is hereby declared to be an emergency measure necessary for the immediate preservation of the health, safety and welfare of the citizens of the Village of Lakemore, Ohio, for the reason that the Lakemore Police Department requires sufficient staffing. Therefore, this Ordinance shall go into effect immediately.
