Section 3: That a certified copy of this Resolution shall accompany the contract signed by the Mayor and shall be forwarded to the President of Springfield Soccer Club.



Section 3: That a certified copy of this Resolution shall accompany the contract signed by the Mayor and shall be forwarded to the President of S.T.A.L..



Paramedic, effective immediately.




