Mayor's Reports

Mayor Justice announced the Village of Lakemore applied for funding through CDBG to afford the engineering work for the Sanitarium Road Improvement Phase I. The application will be reviewed by the CDBG board and Summit County Council in August. The funding is necessary to be eligible for further funding.

Council Committee Reports

Mrs. Cochran announced the next Council meetings will be Tuesday, September 8, 2015, and September 21, 2015, at 7:00 p.m. Mrs. Cochran mentioned Tuesday, September 8, 2015 will also be Primary Election; so Council meeting may be held in fire bay.

Mrs. Cochran also announced the next Council workshop will be at August 5, 2015, at 6:00 p.m.

Mr. Cole announced the free summer lunch program provided for kids under 19 years old at Lighthouse Church on Kubler.

Mr. Cole announced Lakemore United Methodist Church is hosting a community BBQ at Dodd's Lakefront Park on Saturday, August 1st between 5:30 and 9:00 p.m. Free food and music provided.

Mr. Cole also announced Saturday, August 15th between 2:00 and 6:00, a Field Day will be held at Super Learning Center. Free backpacks with school supplies and drawings will be provided. Donations are being sought to afford as many supplies as possible.

Mr. Lance announced the Regional Income Tax Agency will hold another local income tax subpoena program. Representatives will be present at the Lakemore Municipal Building on November 12, 2015. This will give residents who have not filed local income taxes or owe to comply.

Mr. Lance also announced the Lakemore website is working. Residents have the ability to submit a meter reading on the front page of the site.

Mr. Timko announced Ms. Snyder will hold youth art workshops the second Tuesday of each month, excluding the month of August, at 5:00 p.m.

Appearing Before Council ALL comments will be kept under 3 Minutes Sherry Blair, Project Director, Child and Family Health Services provided information regarding "August is Summit Kids Month". Weekly topics were explained. Kellie Cartner provided the successes of "Rock the Run" 5k. She thanked all the sponsors. She reported 58 people registered, and 45 people participated. \$1400.00 was donated to Muscular Dystrophy from the event.

Mr. C.C. Bittner announced he will chair the Lakemore Fire Department Levy Committee. He explained the levy is necessary to maintain the current services provided as well as establish planned funds so the Village may exit Fiscal Emergency. The Fire Levy Committee will announce future meetings and encourage the public to become involved.

Mr. Bittner congratulated Chief Saley for his promotion and future endeavors. He also recognized Shawn Parsell for accepting the Chief's position on a part-time, temporary basis.
