AN ORDINANCE TO AMEND ORDINANCE 1510-2014 AND THE "EMPLOYEE POLICIES AND PROCEDURES MANUAL FOR THE VILLAGE OF LAKEMORE" BY AMENDING HOLIDAY COMPENSATION FOR PART-TIME EMPLOYEES

Now, Therefore, Be it Ordained by the Council of the Village of Lakemore County of Summit, State of Ohio:

Section 1: Council approves to amend Ordinance 1510-2014, Section 6.02 Holidays to read:  
"Each part-time employee of the Village of Lakemore shall be granted compensation at 1 and ½ times his or her hourly rate for the following legal holidays: New Year's Day, Memorial Day, Fourth of July, Thanksgiving Day, Christmas Eve, Christmas Day, and New Year's Eve.

Section 2: That, except as amended herein, the existing provisions of Ordinances 1336-2003 and 1510-2014 shall remain in full force and effect.

Section 3: This Ordinance shall go into effect on and after the earliest period allowed by law.

AN ORDINANCE TO AMEND ORDINANCE 1025-1984 BY AMENDING AND ESTABLISHING  
SPEED LIMITS
